**POSSIBLE OR CONFIRMED CASES OF COVID-19**

KICK then need to be informed of the results of the test.</p> <p>*If the test is negative, the child can return to camp. If, however, the child is unwell, they should not return to camp until they are fully recovered. Once they are well and have not had a fever in the last 48 hrs, they can return. If not, they should continue to self-isolate until fever-free for 48 hrs.</p> <p>*If the test returns positive, parents / guardians within the bubble will be notified of the day the symptoms appeared. ## Risk Rating Calculator

Likelihood that the hazardous event will occur:	
1	Very Unlikely
2	Unlikely
3	Fairly likely
4	Likely
5	Very likely

Consequence of the hazardous event should it occur:	
1	Insignificant – No Injury
2	Minor – Minor injuries requiring first aid
3	Moderate – Up to three days absence
4	Major – More than seven days absence
5	Catastrophic - Death

Risk Rating:	Action:
20-25	STOP – Stop activity and take immediate action
15-16	URGENT ACTION – Take immediate action and stop activity if necessary, maintain existing controls rigorously
8-12	ACTION – Improve within specified timescales
3-6	MONITOR – Look to improve at the next review or if there is a significant change
1-2	NO ACTION – No further action but ensure controls are maintained and reviewed
